Accreditation Report Executive Summary

• General information on the education programme

The Doctoral Programme in International Relations aims to train a high level researcher and practitioner of international relations, who is familiar with the theoretical approaches of international policy, as well as theoretical scopes in politics, economics, law, sociology, and modern international political processes. The main part of the Programme is dedicated to research. Also it contains an teaching component.

Brief overview of the accreditation site-visit

The accreditation site-visit to the Tbilisi State University took place on 11 September 2018. The Expert Panel hold meetings and interviews with the University administration, the Self-evaluation team, with faculty full time and invited members and PhD supervisors, programme students, representatives of employers, University and faculty quality assurance unit heads. At the end of working day the Expert Panel made preliminary presentation of the main findings.

Summary of education programme's compliance with the standards

The Expert Panel on the basis information collected through programme Self-evaluation Report, relevant enclosed documents and the Site Visit discovered that in general the Programme meets all accreditation standards. More specifically the Programme substantially complies with requirements related with educational programme objectives, learning outcomes and teaching methodology and organization. Full compliance with requirements can be seen against standards related with student achievements and individual work with them, teaching resources and teaching quality enhancement.

Summary of Recommendations

The Expert Panel formulated the following recommendations:

- to elaborate new version of learning outcomes description and to deliver it in more detailed and specific manner with direct application to the content of the International Relations discipline';
- to update the list literature provided in the Syllabus of the elective academic course "Modern Debates in International Relations" in order to meet standard requirement of taking new research findings and modern scientific achievements into consideration.
- Summary of Suggestions

The Expert Panel formulated the following suggestions:

- to make Programme admission preconditions and procedures as well as content and course descriptions accessible also in English language with the perspective to give the Programme more international visibility and attract international students;
- to elaborate a strategy and foresee resources for gradual "returning" faculty members from other jobs and providing for them full time employment with adequate salary in order to achieve high level research and high quality international publications.

• to continue fund raising process and develop further international links with relevant foreign scholars to ensure the continuing international excellence.

- the content of the Programme was developed in cooperation with the foreign university with high reputation (in this case the Oxford University);

After the analysis of the Self-evaluation Report, relevant enclosed documents and the Site Visit the Expert Panel discovered that in general the Programme learning outcomes are consistent with the programme objectives. According to the Programme description graduates are able to independently conduct innovative research and analytical work for the implementation of international and foreign policy issues; to do professional work in the civil services, in public sector and international organizations, also to teach in HEI using modern methodologies.

The description of learning outcomes includes all needed components as (a) knowledge and understanding, (b) ability to apply knowledge; (c) ability to generate new knowledge; (d) necessary communication skills; (e) ability to share knowledge with others and (f) respect for academic ethics. The programme has the Curriculum map with clear indication showing that each course develops particular learning outcome or outcomes.

As concerns Programme learning outcomes assessment mechanism the Expert Panel could confirm that the mechanism is in place. The documentation certifying the procedure and discussion of learning outcomes assessment results are foreseen in the rules of the University and in the Charter of the Social & Political Sciences Faculty. The faculty members involved in the Programme are updated in detail on assessment results through the faculty's as well as University's Quality Assurance Service.

The Expert Panel discovered that achievement of the programme's learning outcomes is permanently assessed by the programme's committee on yearly basis. The programme committee at the end of each academic year provides for the head of the program and the International Relations Department its own recommendations and opinions. This mechanism opens direct avenue for the utilizations learning outcomes assessment results for the improvement of the programme as a whole.

On the other hand the description of the Programme learning outcomes still has some space for improvement. It could be less general and more specific with direct references to the content of the International Relations discipline.

After the analysis of the Self-evaluation Report, relevant enclosed documents and the Site Visit the Expert Panel could confirm that the Programme Admission Preconditions take programme characteristics into consideration (it requires at least Master's degree in social and/or humanitarian sciences and a Master's degree in "International Relations" is a priority). This provision ensures admission of the students with relevant knowledge, skills and competences for mastering the programme. The programme admission preconditions are logically linked to the Programme content, learning outcomes and the qualification to be awarded since the applicants are supposed to submit motivation letter and samples of written work related to International Relations. Programme admission preconditions and procedures are consistent with existing legislation. Programme admission preconditions and procedures are fair, public and accessible at least in Georgian language.

2.2 Educational Programme Structure and Content

Programme is designed according to HEI's methodology for planning, designing and developing of educational programmes. Programme content takes programme admission preconditions and programme learning outcomes into account. Programme structure is consistent and logical. Programme content and structure ensure the achievement of programme learning outcomes. Qualification to be granted is consistent with programme content and learning outcomes.

Descriptive summary and analysis of compliance with standard requirements

The Self-evaluation Report, relevant enclosed documents and the Site Visit persuaded the Expert Panel that the Programme is designed according to Tbilisi State University methodology for planning, designing and developing of educational programmes. Its structure is consistent and logical. It comprised of 180 credits with study component of 40 credits and research component of 140 credits. Programme content and structure is consistent with the qualification to the granted and ensure the achievement of programme learning outcomes. The Programme is structured in accordance with Georgian Legislation and European Credits Transfer System. The study component foresees both – mandatory and elective courses. The content of study component takes into account admission preconditions by including into the list of elective courses following subjects as "Classical Texts in International Relations" and "Modern Debates in International Relations". These courses are particularly helpful for students, which graduated from other than International Relations Master's study programmes. The advantage of the research component of the Programme is that it is not limited to the preparation of a doctoral dissertation, but also provides continuous tracking of the process and regular evaluation of achievements in the form of Colloquiums. As concerns the involvement of all stakeholders in designing the programme the Expert Panel could confirm that this standard requirement is being respected.

The Expert Panel on the basis information collected through programme Self-evaluation Report, relevant enclosed documents and Site Visit could confirm that in general student learning outcomes of each compulsory course are in line with programme learning outcomes and each course content and number of credits correspond to course learning outcomes. As regards the standard requirement for Programme content to take new research findings and modern scientific achievements into consideration the Expert Panel didn't discovered any serious discontent, however, it is necessary to make a note that list of literature provided in the Syllabus of the elective academic course "Modern Debates in International Relations" basically refers to literature of the last decade of the 20th century.

The Expert Panel on the basis information collected through programme Self-evaluation Report, relevant enclosed documents and the Site Visit discovered that all necessary students support services are in place. Students receive appropriate consultations and support regarding the planning of learning process, improvement of academic achievement, employment and professional development. In the framework of the Programme, students have an opportunity to participate in local and international projects, events, conferences and research fellowships; they can also participate in international exchange programmes. Students are informed about various local and international projects and events. During the interviews it was confirmed that for the purpose of providing news, the electronic website www.lms.tsu.ge and the closed Facebook group are specially designed for students and professors of doctoral Programme in International Relations. The workload of faculty members includes hours for student advising.

The Expert Panel on the basis information collected through programme Self-evaluation Report, relevant enclosed documents and the Site Visit acknowledges that the human resources of the Programme satisfy requirements of the Standard. Each professor of the Programme has an academic position at Tbilisi State University with full compliance with Georgian legislation and internal regulations of the University. Also, the faculty members possess experience of practical work in public administration institutions and/or international organizations. The number and workload of programme academic/scientific and invited staff ensures the sustainable running of the educational process. 8 professors involved in the Programme are fully capable to manage 13 PhD students enrolled in the Programme. Among them there are 2 full and 3 associate professors directly involved in scientific supervising. The Head of the Programme Associate Professor Tornike Turmanidze has an academic degree of doctor in International Relations and possesses necessary knowledge and experience required for programme elaboration. He is personally involved in Programme implementation. On the basis of the interview with students the Experts Panel acknowledges that Programme students are provided with an adequate number of administrative and support staff of appropriate competence. However, still some international component is missing. Due to the limited funds, it is difficult to invite foreign scholars in order to deliver valuable knowledge to PhD Students.

During the Site Visit interviews with University budget officer the Expert Panel was reassured that financing of the Programme is stable and sustainable. The Programme is financed from the two budgets: the centralized University budget and local budget of the Faculty of Social & Political Sciences, which is basically used for professor's salaries. At the same time the Expert Panel discovered that these salaries are relatively low and faculty members as a rule are also involved in other jobs within or even outside the University in order to generate enough income for financial support of their families. The Expert Panel at this point would like to express a concern and indicate that this situation in the long run may damage successful development and sustainability of the Programme.
