Accreditation Report Executive Summary

General information on the education programme

The BA programme in Law at the law faculty of Tbilisi Humaniatian University is carried out since 2005, first after the institutional accreditation. In 2013 the new Law BA programme was submitted and granted accreditation. Totally programme was modified 5 times, in 2014 changes were made in the programme according to the previous accreditation expert panel recommendations.

Bachelor of Law program, according to the last edition, offers students 320 ECTS credit volume mandatory and elective disciplines. The program is based on theoretical and practical profile. 240 ECTS credits required for granting BA in Law is distributed as follows: -30 ECTS credits are allocated for mandatory courses, including 20 credits dedicated to one European language of the student's choice (English or German); -155 ECTS credits are allocated for the mandatory basic disciplines, including 10 credits - undergraduate research paper, 10 credits - professional practice; Practicum in specialization (5 credits) will be conducted on the basis of the three syllabus - Practicum (moot courts) in Public Law; Practicum (moot courts in private law), Practicum (moot court) in Criminal Law - based on a student's choice; -to be granted 55 ECTS credits, 135 ECTS volume elective disciplines are proposed grouped in 5 modules; The student is entitled to concentrate in the following areas: Law (Law theory and methods, philosophy, history), public (constitutional or administrative) law, private law, criminal law, international law and / or the individual profile formation combining variety of specialized modules and / or academic disciplines (for example, in private law, with administrative law elements, etc.); Law (Law theory and methods, philosophy, history) module includes - 20 credits of elective academic disciplines; Public Law specialization module includes- 40 credits; Private law specialization module -30 credits; Criminal Specialization module - 20 credits; International law specialization module - 25 credits.

Brief overview of the accreditation site-visit

The expert panel spent the first day of the accreditation with briefings from the NCEQE, in comparing readings of the submitted documents, and in preparing questions for the site visit on the second day. The site visit took place on November 6, 2018, It was excellently planned by NCEQE and by THU, and consisted of a tour of the building and inspection of the facilities, and interviews with various groups: senior managers including the Rector and Dean, the QA team, the academic and invited staff, students and alumnis and external stakeholders.

Summary of education programme's compliance with the standards

According to the accreditation standards, BA Law programme:

Standard 1 – complies with the requirements;

Standard 2 – substantionaly complies with requirements;

Standard 3 - substantionaly complies with requirements;

Standard 4 - complies with the requirements;

Standard 5 - complies with the requirements.

Summary of Recommendations

- Grading criteria in most part of the program syllabi is identical and the only difference is in divided points. The expert panel would recommend to organize each syllabi according to the personal interests and viewpoint, course specificity so that academic freedom of each lecturer will be protected.
- In some syllabuses should be given detailed assesement criertias. Also on final and midterm exams students should be suggested exam topics with two or more components to check the knowledge they received during the semester.
- University should check and process assessment criterias in some syllabuses, assessment should be given in detail form and the concrete cryterias should be underlined which will be used by the professor.
- It is very important for internationalization process to develop motivation mechanisms above the students to select the academic staff lectures component led in a foreign languages, (English and German language); This approach is a very good way to develop the foreign language skills. Also involvement in exchange programs, in the various local and international projects, conferences and in other academic activities will help their career future developments. University should focus on establishment of international exchange opportunities for BA law program students. Continue working with existing and new international partners in order to use the best international practice in the program development.

Summary of Suggestions

- It would be better for the university to undertake a minimum level of limit for the national exams and allow more students to learn the program.
- There are opportunities given to the academic and invited stuff to publish their articles in the University's journal organize and participate in conferences proofs that the program objectives are achievable. However, it would be preferable if the University widens these directions and provides more incentives to the academic and invited staff to participate in different academic activities, for instance to involve them in different activities outside the University will it be research, grant projects, scientific conferences etc.;
- It would be better if Online database for instance "Heinonline" will be accessible from the library, to the students. Full access to the mentioned database gives the student top opportunity to study and make research, using comprehensive foreign sources and apply them in their study development.

Summary of best practices (If Applicable)

The University offers elective subject: "Association Agreement between Georgia and the European Union (In June 2014, the EU and Georgia signed an Association Agreement, which entered into force on July 1 2016) both in Georgian and English language, this subject is very useful and internationally oriented one. Also, at the end of the BA program, University offers students so called "Repetitorium"

Course" - This course is established to repeat/review studied basic subjects during the BA program and if needed introduce new topics, amendments and changes in to the Georgian Legislation.

According to the provided documentation and interviews the expert panel concluded that the BA Law programme suggests to the students not only theoretical knowledge but also gives the chance to achieve practical skills which will help the student to use the theoretical knowledge in practice. This situation is in compliance with the demands of labor market and standards.

It should be mentioned that the objectives of the programme is relevant to the mission of the University, is realistic and achievable according to the labor market requirements.

It should be underlined that in the programme are participating high qualified academic and invited staffm who have big academic and practical experience. This fact guarantees that the courses made by them will give the student opportunity to receive not only theoretical but also practical skills. The content of the courses suggested by the programme reflects demands and challenges of local and international market.

The good infrastructure resources of the University also serves the programme to function successfully. Such evidences ensures that the programme objectives are achievable. Students are suggested several elective courses in general, criminal, private and international Law which gives them possibility to deepen their knowledge in desirable field. High qualified academic and invited staff and courses distributed by them gives the student opportunity to easily continue on MA level.

Descriptive summary and analysis of compliance with standard requirements

The courses of BA Law programme, according to the methodology and grades substantially ensures objectives and learning outcomes set by the component. Examination of the syllabuses of the courses given in the curriculum showed that part of syllabus must be checked and processed. In Some syllabuses assessment part is not fully processed and detailed. This means that in some courses achieving final results can occur some problems. Also it should be mentioned that qualification of academic and invited staff can compensate this situation somehow. During the interview the administrative staff of the programme mentioned that they are ready to consider above mentioned issues and recheck syllabuses once again. For example we can point on some syllabuses: "International criminal law", "module of criminal law criminology", "Comparative private law" and etc.

2. Teaching methodology and organization, adequate evaluation of programme mastering

Programme admission preconditions, programme structure, content, teaching and learning methods, and student assessment ensure the achievement of programme objectives and intended learning outcomes.

2.1. Programme Admission Preconditions

Higher education institution has relevant, transparent, fair, public and accessible programme admission preconditions.

Descriptive summary and analysis of compliance with standard requirements

Admission rules for the program are transparent, is accessible to all interested candidates, and provides equal opportunities to participate, for all the candidates with relevant knowledge skills and values.

Admission process of BA Degree is based on Georgian legislation. Every interested candidate who will pass the national exams has opportunity to study at BA program. In exceptional cases established by law for a foreign citizen or a citizen of Georgia, A person shall be enrolled in accordance with the

other rules established by the Ministry of Education and Science of Georgia on the basis of the Academic Council decision.

Persons interested in entering the Bachelor Program have a relatively high minimum limit on national exams, this means that the university does not receive students who overcome the minimum level of national exams, but could not pass the limit established by the university. This fact ensures high level of enrolment, on the other hand this is a basis, for which small number of students are coming to the relevant program, and it can become challenge for the sustainability of the Bachelor Program.

Programme is designed according to HEI's methodology for planning, designing and developing of educational programmes. Programme content takes programme admission preconditions and programme learning outcomes into account. Programme structure is consistent and logical. Descriptive summary and analysis of compliance with standard requirements

BA program is based and developed on legal demands. Program combines modern approaches and attitude, meets modern market needs and fully highlights admission requirements. Also, learning outcome results are transparent that also meets modern standards.

Program is structured in a way that students can comfortably pursue next quarter studies. It is guaranteed by the courses that student can take as a relative discipline.

Program is based on plan – implement – check- develop principle, which gives the university the opportunity to continuously conduct monitoring, identify problems quickly and plan appropriate measures to eliminate problems.

In the program the system of prerequisite is constructed logically, which gives students the opportunity to overcome the compulsory subjects.

There is a lot of elective subjects in program, which give an opportunity to student to plan the semester according to his/her interests. Also should be mentioned importance of practical component in program. Student has possibility to pass practice in legal clinic of university, which is functioning correctly and also has many real case that's why work in above mentioned clinic gives real experience to student.

2.3 Course

As for the number of credits and specific course results, credits, course content and its volume are interrelated. Totally the student must accumulate 240 ECTS to obtain the BA Degree.

University owns one of the most qualitative electronic database "Hein Online", which gives to all interested parts involved opportunity to make research on every field; step forward in the research process and do not limit their choice. This gives an opportunity to student in case of interest to involve in important process. In addition, university has a library where all necessary literature is available for a student to implement research according to their research interests.

University has concluded memorandums to different private or public institutions. Based on this memorandums Students are sent for practice courses. Students have lots of opportunities to use theoretical knowledge gained during the studying process and develop practical skills.

University pays attention to research component and gives students wide opportunities to step forward and participate in various research projects.

The university participates and organizes scientific conferences and BA program students are given an opportunity to be involved in these activities according to the spheres of their interest, as well as write publications and statements which is directly linked with enhancing their professional skills. Besides, the university covers the costs for publishing of the articles prepared by the students and facilitates the process of publishing thereof in different international journals. It should be emphasized, that the quality of the above mentioned articles is being monitored which serves as a guarantee that the product is in compliance with the requirements.

BA program is distinguished and student-centered learning academic program. Its aim is to give the student an opportunity to be involved in different activities planned by the Head of the program. The program is also oriented on practical activities so that the student can be competitive on labor market.

To be noted, learning techniques is corresponding to BA level. Also, each learning component is related to the main content of the program and is oriented on learning outcomes.

2.6. Student Evaluation

Student evaluation is conducted in accordance with established procedures. It is transparent and complies with existing legislation.

Descriptive summary and analysis of compliance with standard requirements

It should be noted that, grading of the students is regulated by the law, according to the interviews of students and academic personal the system is transparent.

It should be noted that in the majority of syllabi the evaluation criteria are very general and are not presented in the form. For example, evaluation system in this different subjects as: "Intrnational Criminal Law", Criminology, and international private law are different, that means that not only academic, but administrative stuff is also involved and prepared in organizing evaluation processes. That means students have opportunity to prepare in advance to certain type of discipline which provides complete studying process.

For example, subject "General Part of Criminal Law" where is mentioned that midterm exams includes theoretical issues and case studies, but there is not mentioned how many cases are analyzed, what is meant by theoretical issues and what is the number of criteria that is presented to the student, the specific points for what criteria are allocated and how student will be evaluated. Also subject "introduction to civil law" where is mentioned final exam is conducted in written form and its duration is 2 hours. In this case it's general and student does not has opportunity to create an idea in advance how he/she will be evaluated. The same situation is in subject "international law of human rights" and also in other syllabi. The existence of these facts indicates that academic staff is less involved in organizing the assessment system and is mainly prepared by administrative staff. This circumstance is also the basis that the student does not have the opportunity to pretend and prepare for a particular discipline examination that prevents the conduct of the full-fledged learning process. Moreover, after interviewing academic stuff, despite of the fact that its provided by syllabi to solve once case which is 5 point, factually, solving the cases occur weekly, which is inconsistent to the evaluation criteria foreseen by syllabi.

It's also important to be pay attention about the syllabi, where its noted that in the part final exam or mid-term exam student is evaluated only by one component. For example, "law of rome", in this discipline students will have 30 multiple choice questions. It should be noted that it will not reveal the real knowledge of the student. Therefore, it should be offered hybrid option. The same situation in the discipline of "world of state and law".

But in the context of the abovementioned syllabus, we see problems in evaluation of mid-term and final exams, such as "Repetitorium in the specialty", part of the evaluation in the Syllabus of these subjects is very general and not specific (detailed), which raises the question marks and there is a threat to have a planned outcome.

3. Student achievements and individual work with them

HEI creates student-centered environment by providing students with relevant services; programme staff ensures students' familiarity with the named services, organizes various events and fosters students' involvement in local and/or international projects.

3.1. Student support services

Students receive appropriate consultations and support regarding the planning of learning process, improvement of academic achievement, employment and professional development.

Descriptive summary and analysis of compliance with standard requirements

Based on the Self-evaluation report of the educational program with relevant enclosed documents, information of the accreditation site visit results, Tbilisi Humanitarian Teaching University LTD (hereinafter referred to as Higher Educational Institution/University) and as a result of the study and development of the Bachelor's degree Program of Law (hereinafter referred to as BA Program of Law), have been observed the following conditions: Educational Process Regulation Rules and Conditions by the Internal Legal Acts are determined clearly and well. It shall be noticed that information necessary for students in reference to the educational process and explained clearly in details. Students received proper consultations and support regarding the planning of learning process, improvement of academic achievement, employment and professional development. Faculty Administration, Head of the program and program academic staff are always ready to support students in planning their individual study plan and to answer students questions related to learning process. Students have opportunity to form their semester study plan during the academic registration, they can choose academic courses from elective subjects. As students note, procedures established by the Internal Legal Acts are available and easily understandable for them. Administration of the University cares on provision of all necessary information for them. A relevant electronic database exists for planning and implementation of the educational procedures. By means of them, students are provided with the detailed information on the educational process. Based on students' interviews university administration and academic stuff is very supportive and

useful in the process of planning of each student's individual academic schedule. Timetable of lectures are flexible and students have opportunity to select suitable time for them.

One library spaces is available for the students, and PC study room. University Library is determined with the literature of multi profile content, mostly in Georgian Language, including, all the necessary books for BA law program under the syllabus. Legislative Herald of Georia's online database; Cambridge journals Online, e-Duke Journals etc.(Agreement. N2018/29) are fully accessible. Online Library is also accessible, most of the books in other languages are accessible online, full access to the mentioned databases and library gives the student opportunity to study, using comprehensive foreign sources and apply them in their study development. The library has an electronic catalogue which is flexible. Students can use primarily the books themselves. A librarian facilitates distribution of the books.

In the scheme of engagement of the academic staff in the component of work with the BA students, availability of academic and invited personnel was ascertained. Individual meetings and consultations are also facilitated by the University. University provides students with information on conferences and moot courts, public lectures, supports how to apply for them, also itself it implements encouragement of successful students with scholarships. Students participate in local and international conferences, in imitated processes, University provides courtroom for Moot Courts, with all the necessary equipments.

The University is not involved in the Erasmus Program, but has partner universities where students can participate in exchange programs. The University implements the analysis of the program outcomes by the students to apply them for the future confirmation of achievements and facilitates further development of the educational programs. BA program of law, developed by the University, facilitates the student to evolve specific skills needed to develop their practical skills. In students opinion, the names and directions of the subjects are well established. The University offers BA students subject of Legal English and the academic staff lectures component led in a foreign languages, (English and German language); This approach is a very good way to develop foreign language skills. Employment prospective exists -Students are informed regarding the internship and employment opportunities. One semester is dedicated to professional practice. Students can choose practice options considering their interests. The University provides information on the vacancies and has an agreements on internship, between potential employers. Employers choosing interns above the students. some of them became employed and are still working there. Baccalaureate students of Law Clinic are fully involved. Their duties include: participation in the preparation of the documents, practicing lawyer managing the mentioned process. The information about planned projects, events and other activities are very transparent and each student has opportunity to participate. Despite the above-mentioned facts BA students' involvement rate in selecting the academic staff lectures component led in a foreign languages, (English and German language), exchange programs, scientific and other academic activities is very low. Students mentioned during the interview that some of them are interested in exchange programmes. But anyway there is a lack of international activities. Furthermore, students English language knowledge is not very high, which also prevents them to select subjects in English Language, participate in international projects and other academic activities.

Based on the Self-evaluation report of the educational program with relevant enclosed documents, information of the accreditation site visit results, Tbilisi Humanitarian Teaching University LTD (hereinafter referred to as Higher Educational Institution/University) and as a result of the study and development of the Bachelor's degree Program of Law (hereinafter referred to as BA Program of Law), have been observed the following conditions: The BA Law programme is served by the academic and invited staff of the University. All of them have the relevant qualification to conduct the proper teaching in their field. Most of them have the PhD in Law and are actively involved in professional development process. The Bachelor's programme academic/scientific and invited staff Members are involved have all the necessary competences in order to help students achieving the programme learning outcomes (including publications, professional experience, relationship with foreign university colleagues, involvement in international programmes). Programme academic/scientific staff is also in accordance with the sustainability of the educational process, which ensures the achievement of the program objectives. The main objective of BA Program is to provide the students not only with the theoretical knowledge and understanding of legal issues as well as to assure that the students have acquired the practical skills to use the theoretical knowledge in practice which is one of the crucial aspect for their future development. Academic and invited staff having a strong educational background and simultaneously a wide practical experience in the field of their teaching. The courses designed and taught by such professionals enable students not only to gain the theoretical knowledge in the relevant subject, but also to learn specifically how to apply it in practice.

Opportunities given to academic and invited stuff to publish their articles in the University's journal organize and participate in conferences proofs that the program objectives are achievable. However, it would be preferable if the University widens these directions and provides more incentives to the academic and invited staff to participate in different academic activities like conferences, trainings etc.

The lectures are taught not only by the University's academic staff having academic degrees, strong academic background, long-term experience in teaching and research activity in the particular field of law, but also by invited lecturers as well as assistant professors among which are practitioners in the particular law direction and have high qualification in their profession. The BA Head of the Programme has the high competences and experience to run it and is involved in the organization of the Programme. Students are provided with an adequate number of administrative and academic staff. The experience related by the Students and Alumni during the interviews site visit confirms this point as well. Students and Alumni stressed the very useful and flexible way the BA Programme is organized and mentioned the fact that their choice for this program was the Head of the Program, academic and invited professors name and their qualification.

4.3. Material Resources

Programme is provided by necessary infrastructure and technical equipment required for achieving programme learning outcomes.

Based on the Self-evaluation report of the educational program with relevant enclosed documents, information of the accreditation site visit results, Tbilisi Humanitarian Teaching University LTD (hereinafter referred to as Higher Educational Institution/University) and as a result of the study and development of the Bachelor's degree Program of Law (hereinafter referred to as BA Program of Law), have been observed the following conditions: University is equipped with modern technologies. Every classroom has the computer and projector. Administration of the University cares on provision of all necessary information for them. A relevant electronic database exists for planning and implementation of the educational procedures. By means of them, students are provided with the detailed information on the educational process. Based on students' interviews university administration and academic stuff is very supportive and useful in the process of planning of each student's individual academic schedule. Timetable of lectures are flexible and students have opportunity to select suitable time for them.

One library spaces is available for the students, and PC study room. University Library is determined with the literature of multi profile content, mostly in Georgian Language, including, all the necessary books for BA law program under the syllabus. Legislative Herald of Georia's online database; Cambridge journals Online, e-Duke Journals etc.(Agreement. N2018/29) are fully accessible. Online Library is also accessible, most of the books in other languages are accessible online, full access to the mentioned databases and library gives the student opportunity to study, using comprehensive foreign sources and apply them in their study development. The library has an electronic catalogue which is flexible. Students can use primarily the books themselves. A librarian facilitates distribution of the books. Students participate in local and international conferences, in imitated processes, University provides courtroom for Moot Courts, with all the necessary equipments. To increase and improve the internationalisation process and international relationships teaching of English is very important. English language courses or course of professional English are included in the programme but after interviews with the students and graduates we discovered that interest to select subjects in foreign languages (English and German Languages) is very low. This situation reduces the opportunity for the students to take part in exchange programmes and to use foreign materials while studying process.

Also, it includes the scientific leave, promotion, scholarships for students, purchasing the literature costs, publishing costs, which covers the scientific journal publishing payments. The Law School has a budget in accordance with its objectives and the requirements of the Bachelor's law Programme. By the way, Budget Heading Research Coast/ Staff Research Projects/Literature could be, if possible, reinforced, including exchange programmes, participation in international events, both for students and academic/scientific stuff.

5. Teaching quality enhancement opportunities

In order to enhance teaching quality, programme utilizes internal and external quality assurance services and also periodically conducts programme monitoring and programme review. Relevant data is collected, analysed and utilized for informed decision making and programme development on a regular basis.

5.1 Internal quality

Programme staff collaborates with internal quality assurance service(s) available at the higher education institution when planning the process of programme quality assurance, creating assessment instruments, and analysing assessment results. Programme staff utilizes quality assurance results for programme improvement.

Descriptive summary and analysis of compliance with standard requirements

The quality assurance department of the University regularly monitors the programme. For that reason regular assessment of the students and academic staff is done by using the surveys. The analysis of such assessment is used to develop the programme. Also it should be mentioned that before the site visit was held the head of the quality assurance department was changed. During the interview with the new head of the department the expert panel had the impression that in the future monitoring and developing of the programme will be carried out more frequently. During the interviews, expert panel was informed that the University is permanently taking into consideration the suggestions and ideas of the students. For example more hours were given to the practical component, also the course of criminalistics was removed from the curriculum of the programme. The quality assurance department controls and monitors the quality of the lectures

conducted by the academic and invited staff, also the research activities of the academic and invited staff is checked, all this activities are very important for future programme functioning.

Very important mechanism of monitoring the programme is peer review method, which means collaboration between the academic staff and University about the content of the programme. Also the University have implemented the internal assessment mechanisms, which means that University conducts the quantitative and qualitative research to analyse
