Accreditation Report Executive Summary

· General information on the education programme

New Vision University (hereinafter the "University" of HEI") was founded in 2013 in the form of nonentrepreneurial (non-commercial) legal entity, which is comparatively new development in the higher educational sphere of Georgia. While the University's educational activity is not-for profit, the HEI has a realistic mission to expand the human vision "through promotion of education, research and innovation":

Although the University was founded in 2013 and does not have a long-term experience in higher education, it has gained the reputation in the Georgian society. It has employed carefully selected academic and invited staff having a strong educational background and, as well, wide practical experience in the field of their teaching. The Program structure is in compliance with the applicable Georgian legal regulations, correspond to the current local and international legal market demand.

According to Self-Evaluation Report ("SER"), the PhD Program aims to "contribute to the free development of an individual and expansion of human vision through enhancement of the existing knowledge and establishment of innovative methods in law-making and/or interpretation of legal rules", (SER, p. 10). The Program objectives are in full compliance withHEI mission and are realistic and achievable.

The University has a strong international partnership policy and uses it as well for the development and improvement of its Phd program.

The students-oriented Phd Program offers them very qualified thesis supervisors. The qualifications and the number of the teaching/scientific/invited staff in the Programme are perfectly adequate to ensure expected learning outcomes and meet the legal requirements. Teaching/scientific/invited staff is really well-known in national academic and professional environment. This brings very successful practical and professional experience, which is supporting the ongoing innovative process of the Programme.

Brief overview of the accreditation site-visit

The Phd Program site-visit took place the 11th of October 2018. Different necessary meetings had been organized, starting with the the Self-Evaluation Team, the QA Head and the Head of Programme, the Dean of the Law Faculty, followed by meetings with academic and invited staff, PhD Supervisors, PhD Students, Alumnus as well as meetings with employers and internship supervisors (regarding all three programs).

A Tour of the Institution was also organized (libraries, classrooms, offices, buildings, which revealed a very active and innovative infrastructure policy);

The different interviews provided: - first, all necessary information concerning the organization of the over mentioned Program (innovative, high availability of Academic Staff, high level of supervision of students); high availability of academic/scientific staff as well as professionals/employers in Teaching and supervising Doctoral Thesis and internships.

Second, demonstrated the serious and innovative way of organizing PhD Studies; A program where Students are as much involved, guided in their work on a very regular basis. The way of Teaching/conducting and supervising Research suits perfectly with the necessary adaptation of traditional teaching/conducting/supervising Research to the evolution of society and the local, national and international labour market. Thesis Subjects chosen by Phd Students are useful for the market/innovative is the flied of law. The learning outcomes of the program are very clearly established, described and precise that knowledge and skills the graduate will have.

Summary of education programme's compliance with the standards

The Expert Team obtained a very positive overall impression of the Programme with regard to content, level of definition, structure and suitability, also with respect to academic and professional demands, as well as the NVU strategy and strategical plan for academic development and updating of the curriculum competences.

The expert Team was impressed by the very innovative, student oriented, market oriented way the PhD program is organized.

The main objective and intended learning outcomes of the Programme are enabling students to obtain necessary legal competences and skills, enabling them to perform practical legal work in national or international legal environment.

Programme aims and learning outcomes are properly defined.

Teaching resources (human resources professional development of academic, scientific and invited staff, material resources, budget) are adapted to the program's aims and future development.

Summary of Recommendations

Grading criteria in most part of the program syllabi is identical and the only difference is in divided points. The expert panel would recommend to organize each syllabi according to the personal interests and viewpoint, course specificity so that academic freedom of each lecturer will be protected.

Summary of Suggestions

Due to the very positive way the Phd Program is organized, it could be useful to pay more attention to the publicity and marketing of the programme.

Continue working with existing and new international partners in order tu use the best international practice in the program development.

It could also be of interest to apply for European/International quality assurance process, like the one proposed, for example, by the EUA (European University Association). This kind of initiative would also contribute to national and international visibility.

Continue working on internationalization, increase number of international projects for academic staff and students, continue regularly organize international conferences, implement research activities etc.

If the way Governance is organized is one of the parameters beyond others which fosters scientific and career development, it could be of use to organize on a regular basis (but not to binding), meetings with academic/scientific staff/invited staff), in order to exchange experience and boosting, as an example, collective research projects on local and international level as well as scientific and career development.

This non binding suggestion of course is the result of what was actually mentioned during interviews. It could, in our opinion booster for example more collective and interdisciplinary projects.

More documentation in foreign languages inside the libraries is of course always necessary, even if online documentation is available. Indirectly linked to material resources, but always of use as well: Reinforcing international parnerships, on a geographic and strategic basis. This could as well contribute to the added value mentioned above (for example, more comparative thesis subjects).

The University/School of Law could, in order to deeper achieve its objectives, try to more develop a grant's policy for Students and Academic/scientific staff (even if Foundation grants are already existing) and make it more readable in the presentation of the budget. This could also contribute to the attractiveness of the programme.

In relation with comments above, it could be also of interest to reinforce the University's/School of Law application for international research grants/programmes. Besides increasing the Research/PhD Budget, it would also positively contribute to the international visibility of the Institution.

· Summary of Best Practices

The objectives of the program and the learning outcomes are mutually harmonious and condition each other, meanwhile the learning outcomes are precisely based on what methods they are guiding while mastering it.

The PhD program is aimed at step by step, correctly processing and defining the dissertation work. The university approach is to develop and correctly define the skills of time, which helps the student to accurately determine the subject matter and reach specific conclusions. This approach is especially important for students who are the practicing lawyers employed by their profession, in giving them the right direction during the given process is carrying a substantial importance. Therefore a topic processing procedure is correctly ruled and the final result is simply achievable. There is a large number of interesting and in hand topics, based on the needs of the market.

The way the Programme is organized (Teaching and Research Component/Teaching Methodology/clrear deadlines for the achievement of the Student's Thesis/Colloquiums which are part of disseration, etc) makes it exceptionally effective and could become a model for other Higher Education Institutions).

1. The New Vision University (hereinafter the "University" of HEI") was founded in 2013 in the form of non-entrepreneurial (non-commercial) legal entity, which is comparatively new development in the higher educational sphere of Georgia. While the University's educational activity is not-for profit, the HEI has a realistic mission to expand the human vision "through promotion of education, research and innovation" (University Charter; Self-Evaluation Report, p. 10).

According to Self-Evaluation Report ("SER"), the PhD Program aims to "contribute to the free development of an individual and expansion of human vision through enhancement of the existing knowledge and establishment of innovative methods in law-making and/or interpretation of legal rules", (SER, p. 10). The Program objectives are in full compliance with HEI mission and are realistic and achievable as evidenced by SER, PhD Program, site-visits and interviews with various stakeholders of the University.

Although the University was founded in 2013 and does not have a long-term experience in higher education, it has gained the reputation in the Georgian society. It has employed carefully selected academic and invited staff having a strong educational background and simultaneously wide practical experience in the field of their teaching. The Program structure is in compliance with the applicable Georgian legal regulations, correspond to the current local and international legal market demand and echoes the challenges and developments in the legal sphere. Most importantly, the issues to be researched in dissertations are selected in order to reflect and address the topics, which are mostly problematic in the legal sphere and are in need for deeper analyses and research. All the indicated basic factors in addition to sufficient infrastructure and resources provide necessary arguments in favor of the conclusion that the objectives of PhD Program are realistic and achievable.

Descriptive summary and analysis of compliance with standard requirements

The main method employed at the Program is "learning by Doing". While in the first semester students should undergo the core course of "Basic Tools for PhD Research" enabling students to gain the necessary knowledge for PhD research, the second semester provides the possibility for students to compose their own profile. This system operated at the University according to which the freedom and opportunity is provided to each student to create his/her own profile through the choice of accomplishing core teaching components or conduct a professor guided research, take the teaching methods II when demonstrating specific interest in teaching course or take II Seminar when willing to expand additional research, corresponds to the University's main objective of "offering educational programs promoting the free development of an individual" (HEI Charter, Article 3). In addition, students who are practicing attorneys may act as supervisors at the University's Legal Clinic which facilitates the development of their teaching skill component.

The student-oriented system considers the student as the major stakeholder of the University and evidences the University's positive approach on student-oriented teaching (SER, interviews with students administration, academic and invited staff).

The existence of "simple bureaucracy" system enables students to easily communicate with the administration and their professors on the issues they are concerned with. Both the administration and academic/invited staff consider students as major evaluators of the program objectives and learning outcomes. While students and professors fully share the HEI mission and PhD Program objectives, professors have the independence in the process of decision-making in terms of their courses. Students can easily communicate with the administration and their professors on the issues they are concerned with.

The interviews conducted with different stakeholders showed not only the interviewers' deep knowledge of the HEI mission and the PhD Program objectives but their involvement in the process of goal achievements.

In the admission process, important attention is given to the candidate's letter of motivation, and, in addition to the supervisor's recommendation, that is based on academic and practical work experience and skills, that is highly important for the program, which was also confirmed at the interviews with the academic staff and the students.

It can be noted that the Admission procedure at the PhD level is in accordance with the Georgian legislation.

PhD program involves and pays sufficient importance to practical components, students have internship opportunity through various activities of law clinic, which is loaded with cases and gives students chance to enlarge practical experience.

University pays attention to researchers and gives students wide opportunities to participate in various research projects.

The university participates and organizes scientific conferences and PHD program students are given an opportunity to be involved in these activities according to the spheres of their interest as well as write publications and statements which is directly linked with enhancing their research potentials/skills. This is documented and also confirmed at during the interviews with the PhD students.

Besides, the university covers the costs for publishing of the articles prepared by the students and facilitates the process of publishing thereof in different international journals. It should be emphasized, that the quality of the above mentioned articles is being monitored which serves as a guarantee that the product is in compliance with the requirements. It would be preferable if the university had separated budget for the students who are interested in International Researches. But according to their interviews, students don't have sufficient time to go abroad and they prefer to do the research in Georgia.

Based on the Self-evaluation report of the educational program with relevant enclosed documents, information of the accreditation site visit results, NNLE New Vision University (hereinafter referred to as Higher Educational Institution/University) and as a result of the study and development of the PhD Program of Law, have been observed the following conditions: Educational Process Regulation Rules and Conditions by the Internal Legal Acts are determined clearly and well. It shall be noticed that information necessary for students in reference to the educational process and explained clearly in details. As students note, procedures established by the Internal Legal Acts are available and easily understandable for them. Administration of the University cares on provision of all necessary information for them. A relevant electronic database exists for planning and implementation of the educational procedures. By means of them, students are provided with the detailed information on the educational process. Two library spaces are available for the doctorate students, the newest apple-PC study room, which are also used for mid-term and final exams. University Library is determined with the literature of multi profile content, including, books in German and English languages, as well as unique books. Online database "Heinonline" is also accessible from the library, full access to the mentioned database gives the student top opportunity to study and make research, using comprehensive foreign sources and apply them in their study development. The library has an electronic catalogue which is flexible. Students can use primarily the books themselves. A librarian facilitates distribution of the books. In the scheme of engagement of the academic staff, supervisors in the component of work with the PhD students, availability of academic personnel and tutors was ascertained. Individual meetings and consultations are also facilitated by the University. Since the students are engaged in their profession, time of lectures are maximally adjusted to the students daily schedule which makes the learning most flexible. University provides students with information on scholarships of local scientific funds and Supports how to apply for them, also itself it implements encouragement of successful students by financing or co-financing of the projects submitted by them. Students participate in local and international conferences, in different other scientific activities throughout Georgia, as well as in similar activities abroad. The University expresses support to its students and, if necessary, is ready to grant internal (in-University) grants for both doctoral students and academic personnel to finance research projects. The University is also involved in the Erasmus Program, and has partner universities where students can participate in exchange programs. University offers to the doctorate students Lecture component. Employment prospective exists - PhD students are tutoring simultaneously with the status of assistant - leading lectures-seminars up-to the BA Level Course. They get paid for the job. The Program Course content, meaning and objective is relevant to the current needs. PhD students are managing/supervising the process at University's Law Clinic and are paid for their work/partly free of the study fee.

In the process of interviewing students, it became clear that subjects included in the PhD program of law are immensely directed to achievement of the goals of learning, are practically sensible and resultant, oriented on development and defense of high level dissertation works, which meet new challenges and are featured with higher academic and contextual style. Preparation for seminar works and dissertation: PhD program of law, developed by the University, facilitates the student to evolve specific skills needed to develop the dissertation through implementation of particular tasks requiring to analyze the various

4. Providing teaching resources

Programme human, material, information and financial resources ensure programme sustainability, its effective and efficient functioning, and achievement of intended objectives.

4.1. Human Resources

- The Head of the Programme possesses necessary knowledge and experience required for programme elaboration. He/she is personally involved in programme implementation;
- Programme students are provided with an adequate number of administrative and support staff of appropriate competence.

Descriptive summary and analysis of compliance with standard requirements

The Phd Programme Academic Staff Members are involved have all the necessary competences in order to help students achieving the programme learning outcomes (including publications, professional experience, relationship with foreign university colleagues, involvement in international partnerships and programmes). That makes of course no doubt.

The number and workload of the programme academic/scientific staff seems also in accordance with the sustainability of the educational process and its innovative way of running which ensures the achievement of the doctoral thesis. This is of course an important and very positive point to be stressed on, since practice in other institutions can be confronted to non achievement of thesis due, of course to insufficient work of the PhD Student, but also to insufficient involvement of academic staff/scientific staff and insufficient or inadequate organization of a PhD Programme.

The PhD Head of Programme has of course the necessary competences and experience to run it and is involved in the organization of the Programme. That makes no doubt as well.

Finally, students are provided with an adequate number of administrative and academic staff. The experience related by the Students and Alumnu during the site visit confirms this point as well. Students and Alumnu stressed the very innovative way the PhD Programme is organized and runned and mentionned the fact that their choice for this programm was the result of former experience related by others.

It may be stressed that PhD Students are used to work with foreign documentation, articles, books. This I of course an important added value for their final dissertation, even if there seems to be a lack of documentation in Georgian language. This is in part made possible by the very active collaboration of the University/School of Law with partner Institutions in Germany and elsewhere, the very international oriented policy of the University/School of Law. Members of the accreditation team where really impressed by the dissertations they could have access to and read during the site visit. It is, of course, also made possible by the international engagement of the academic/scientific staff which

could be, as mentioned above, be more boosted to increase an already existing scientific and career development and to increase as well national and international visibility.

To be summarized, the environment of the University is designed to ensure the educational process and achieve the learning outcomes envisaged by the program (library/library service center/university electronic resources/literature research international system). If things can always be more developed (for example more updated books in more topics, fields of research), ils had to be stressed that the university, actually a young and dynamic one, is developing its infrastructure policy as was seen

during the site visit (new buildings, new redevelopment).
