Decision

On termination of the administrative proceedings initiated in connection with the - unscheduled monitoring of the Russian-language one-cycle educational programme "General Medicine" of Yerevan State Medical University after Mkhitar Heratsi

1. Legal basis for making a decision

1.1. According to the Article 31, Paragraph 1 of the Accreditation Regulation for Educational Programmes of the Higher Education Institutions, approved by Order No. 65/N of the Minister of Education and Science of Georgia of 4 May 2011, the verification of compliance with accreditation conditions is carried out through planned and/or - unscheduled monitoring.

1.2. According to Article 31, Paragraph 5 of the Accreditation Regulation, - unscheduled monitoring is carried out based on a submitted complaint regarding compliance with the accreditation standards for educational programmes and/or at the initiative of the NCEQE.

1.3. According to Article 31, Paragraph 24 of the Accreditation Regulation, if, as a result of the verification of compliance with accreditation conditions, it is established that part of the recommendations has been fulfilled by the institution and, at the same time, none of the standards is assessed as "does not comply with the requirements of the standard," the Council shall set a deadline for the institution to submit a report on the fulfilment of the remaining recommendations or shall apply to the NCEQE with a motion to carry out monitoring.



Descriptive Part and Rationale

2.1. By Decision No. 160336 of the Accreditation Council for Educational Programmes of 14 February 2024, the Russian-language one-cycle educational programme "General Medicine" of Yerevan State Medical University after Mkhitar Heratsi was granted accreditation for a period of 7 years, subject to monitoring within 2 years.

2.2. In accordance with Order No. 157557 of the Director of the LEPL - National Center for Educational Quality Enhancement of 12 February 2026, "On unscheduled monitoring of the fulfilment of accreditation conditions at the Russian-language one-cycle educational programme 'General Medicine' of Yerevan State Medical University after Mkhitar Heratsi" (amended by Order No. 269221 of 5 March 2026), the accreditation expert panel evaluated the educational programme.

2.3. The Council reviewed the documentation submitted by the institution, the report of the expert panel, and the argumentative position submitted by the educational institution to the NCEQE regarding the draft report of the expert panel.

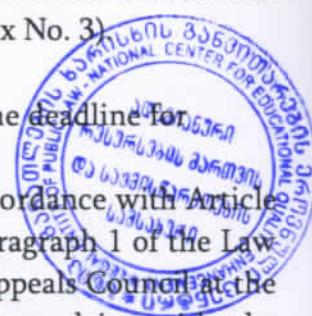
2.3. The Council made its decision based on the documentation submitted by the institution, the report of the expert panel, the argumentative position submitted by the institution to the NCEQE regarding the draft report of the expert panel, as well as after hearing the oral position of the interested party at the session.

3. Resolution Part

In accordance with Paragraph 1 of Article 27² and Paragraph 24 of Article 31 of the Accreditation Regulation, Article 8 of Order No. 233 of the Director of the LEPL - National Center for Educational Quality Enhancement of 1 June 2011 "On Approval of the Case Management Rules and Internal Regulations of the Legal Entity of Public Law - National Center for Educational Quality Enhancement," Article 8 of Order No. 223 of the Director of the LEPL - National Center for Educational Quality Enhancement of 1 June 2011 "On the Approval of the Case Management Rules and Internal Charter of the Legal Entity of Public Law - National Center for Educational Quality Enhancement," and Article 53 of the General Administrative Code of Georgia, the Accreditation Council

decided:

1. The administrative proceedings initiated in connection with unscheduled monitoring of the Russian-language one-cycle educational programme "General Medicine" of Yerevan State Medical University after Mkhitar Heratsi shall be terminated.
2. The educational institution shall be granted the right to implement the Russian-language one-cycle educational programme "General Medicine" in accordance with the data defined in Annex No. 1.
3. The report of the accreditation expert panel on the Russian-language one-cycle educational programme "General Medicine" of Yerevan State Medical University after Mkhitar Heratsi shall be deemed an integral part of this decision (Annex No. 2).
4. Part No. 3 of the minutes of the session No. 600173 of the Accreditation Council for Educational Programmes of 21 May 2026 shall be deemed an integral part of this decision (Annex No. 3).
5. The decision of the Council shall enter into force on 21 May 2026.
6. For the purpose of verifying the fulfilment of the remaining recommendations, the deadline for submitting the report shall be 1 year, by 21 May 2027.
7. The decision of the Council may be appealed by the educational institution, in accordance with Article 180, Paragraph 1 of the General Administrative Code of Georgia and Article 24¹, Paragraph 1 of the Law of Georgia "On Education Quality Enhancement," by submitting an appeal to the Appeals Council at the following address: N2 Merab Aleksidze Str., Second lane, Tbilisi or by filing a claim with the



Administrative Cases Panel of Tbilisi City Court at the following address: 64 Davit Aghmashenebeli Alley, Tbilisi, within one month from the date of notification of the institution, in accordance with the legislation, of this decision and its reasoning parts (Annex No. 1, Annex No. 2, Annex No. 3).
